COMMUNITY SCHOOLS STAFFED BY NNH ARE A COLLABORATIVE EFFORT BETWEEN THE NNH, RED BANK HIGH, HIXSON MIDDLE, SODDY DAISY MIDDLE, SALE CREEK MIDDLE/HIGH AND RED BANK ELEMENTARY SCHOOLS. COMMUNITY SCHOOL COORDINATORS FACILITATE AN AFTERSCHOOL PROGRAM AND SUPPORTS FOR STUDENTS AND FAMILIES DURING THE DAY AS WELL. 98% OF OUR PROGRAM PARTICIPANTS GRADUATED HIGH SCHOOL SLATED TO GRADUATE IN MAY OF 2022 DID.
